

# RDCR - Well Engineering Forum

## 2019 Contract

### General

**Katch Kan Ltd**, hereafter referred to as THE SPONSOR, hereby agrees to sponsor the event, **RDCR**, organised by TMG Worldwide Publishing SL, (herein referred to as TMG/RDCR) with benefits described in the SPONSORSHIP PROPOSAL, a copy of which is attached to this contract. The Sponsor agrees to pay the following fees:

### **1 x Small Technology Information Point - €2,500**

In consideration therefore, TMG/RDCR shall provide the Sponsor with the benefits described in the Proposal. TMG/RDCR may adjust such benefits, substitute benefits or provide other benefits with the approval of the Sponsor.

### Limitation of Sponsorship

Unless otherwise provided, the cash or services and the Sponsor benefits described in this agreement are related solely to the RDCR to be held on April the 11<sup>th</sup> 2019, in Moscow, Russia.

### License and Usage

The Sponsor hereby grants TMG/RDCR a limited, non-exclusive license to use the Sponsor's trade names, trademarks, service marks and other proprietary information [the "Proprietary Information"] owned by the Sponsor. TMG/RDCR agrees that the Proprietary Information will be used only in connection with the 7<sup>th</sup> RDCR to provide the benefits set forth in the Proposal and such other benefits as the Sponsor and TMG/RDCR may agree. TMG/RDCR use of the Proprietary Information is subject to the approval of the Sponsor's designated representative, whose approval will not be unreasonably withheld.

### Sponsor Understandings

The Sponsor understands as follows: the audience multiplier is based upon estimates of TMG/RDCR attendance and actual attendance figures may vary materially. No portion of the sponsorship cash payment are subject to being refunded for any reason except as provided herein. Sponsorships are not exclusive unless otherwise set forth in the Proposal.

### Venue

The RDCR will be held in Moscow at the Kempinski Baltschug Hotel, however the venue of the event is subject to change at any time by TMG.

### Payment

Payment due within 30 days of signing the contract. Failure to pay fees when due may result in termination of this agreement. In-kind services shall be scheduled in writing by representatives of TMG/RDCR and the Sponsor.

### Cancelation/Speaker Substitution

Speaker substitutions are welcome up to 3 days before the event, however cancellations must be submitted in writing at least 4 weeks prior to the event and a credit voucher will be issued for a future TMG event accordingly. Any cancellation received later than 4 weeks prior to the event will be considered as a breach of this contract and no credit will be given. The Sponsor shall not terminate this agreement without the approval of TMG/RDCR. If for any reason the organizers decide to amend, postpone or cancel the event the conference fee will not be refunded.

### Amendments

This agreement may be amended only by a written instrument executed by both parties.

### Miscellaneous

This agreement is governed by the laws of Spain, and is binding upon all of the parties' successors and assigns.
